

The Affordable Connectivity Program supports eligible low- income households struggling to afford monthly internet service. This critical program ensures that households have the connections they need for work, school, healthcare, and more.

What Is the Benefit?

The benefit provides a **discount of up to \$30 per month** toward internet service for eligible households.

The Affordable Connectivity Program is limited to one monthly service discount per household.

Who Is Eligible to Receive ACP Support?

A household is eligible if a member of the household meets at least *one* of the criteria below:

- Has an income that is at or below 200% of the [federal poverty guidelines](#);
- Participates in certain assistance programs, such as SNAP, Medicaid, Federal Public Housing Assistance, SSI, WIC, or [Lifeline](#);
- Participates in Tribal specific programs, such as Bureau of Indian Affairs General Assistance, Tribal TANF, or Food Distribution Program on Indian Reservations;
- Is approved to receive benefits under the free and reduced-price school lunch program or the school breakfast program in the current or immediately preceding school year;
- Received a Federal Pell Grant during the current award year; or
- Meets the eligibility criteria for a participating provider's existing low-income program.

How Does an Eligible Household Enroll in the Program?

Complete and submit an online or mail-in application available at [ACPBenefit.org](https://www.acpbenefit.org) or download and complete the ACP Application below and email to info@leru.net or mail to Le-Ru Telephone Company at P.O. Box 147 Stella, MO 64867.

By emailing or mailing your ACP application directly to Le-Ru Telephone Company, you are giving consent and agreeing for Le-Ru Telephone Company to transmit your subscriber information to the National Lifeline Accountability Database (NLAD). If qualified, the ACP discount will be applied to the following month's bill for current customers. If not currently a Le-Ru Telephone Company customer, you will need to apply for services by completing and submitting an application for services found at <https://leru.net/services>. ALL INTERNET SERVICES REQUIRE A TELEPHONE SERVICE. If eligibility requirements change or if ACP is terminated, you will be responsible to discontinue service or pay the regular service rates to avoid being disconnected. It will not be Le-Ru Telephone Company's responsibility to notify you of any changes to the ACP program. You may obtain ACP-supported broadband service from any participating provider of your choice and you may transfer your ACP benefit to another provider at any time. You remain responsible for monthly payment to Le-Ru Telephone Company for the duration of the services provided. After ACP, Le-Ru Telephone Company's regular rates apply.
